### **Report on the Audit of the Standalone Financial Statements**

#### Opinion

We have audited the financial statements of **Cherry Vogaging Private Limited** which comprise the balance sheet as at 31st March 2021, and the statement of Profit and Loss for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Act in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at 31st March, 2021 and its profit/loss for the year ended on that date.

#### Basis for Opinion

In preparing the financial statements, management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

**I. Significant Accounting Policies:**

**1. Accounting Convention:**

- a. The accounts have been prepared on the historical cost convention and on the accounting principle of going concern.
